# **Cookies Policy**

### 1. Handling of Cookies

Cookies (hereinafter referred to as "cookies") are functions that store information about your visits to websites and other sites on your computer, tablet PC, or cell phone in the device you are using.

By using cookies, it is possible to obtain information such as the number of times your device has visited a website and the pages you have visited.

Our website automatically collects information such as Internet domain names, IP addresses, and the environment in which this website is viewed.

However, unless the user enters personal information, the collected information cannot be used to identify or distinguish the individual and remains anonymous. You can also set your browser to refuse cookies.

### 2. Acquisition and Purpose of Use of Cookie Information

### 2.1 Acquisition of cookie information

"Cookies" are used for some of the services on the Company's website for the purpose of providing better services, such as statistical processing of access information, and are not intended to be used for any other purpose.

Cookies do not violate the privacy of users or their usage environment.

Cookies do not store personally identifiable information in any case.

#### 2.2 Access logs

Our website records information about visitors in the form of access logs, but the access logs themselves do not contain any personally identifiable information.

We collect information on our website for statistical analysis of usage and to improve the usability of the website.

Google Analytics uses cookies to collect user information, but does not collect information that identifies individual users.

The information collected is anonymous and does not correlate access information with the visitor's personal information.

The results of the analysis are used for the purpose of improving the quality of this site and creating better content.
